### Order 2021-23 of the Minister of Transport dated 18 November 2021

Act respecting off-highway vehicles  
(chapter V-1.3)

Regulation to authorize the operation of certain off-highway vehicles on roads under the management of the Minister of Transport

THE MINISTER OF TRANSPORT,

CONSIDERING subparagraph 7 of the second paragraph of section 73 of the Act respecting off-highway vehicles (chapter V-1.3), according to which the Minister of Transport may, by regulation, determine the off-highway vehicles that are authorized to be operated on all or part of a road that the Minister is responsible for maintaining;

CONSIDERING the seventh paragraph of section 73 of the Act, which provides that such a regulation is not subject to the publication requirement or the date of coming into force set out in sections 8 and 17 of the Regulations Act (chapter R-18.1) and it may come into force on the date of its publication in the *Gazette officielle du Québec*;

CONSIDERING that it is expedient to make the Regulation;

ORDERS AS FOLLOWS:

The Regulation to authorize the operation of certain off-highway vehicles on roads under the management of the Minister of Transport, attached to this Order, is hereby made.

Act respecting off-highway vehicles
