### Tariff of costs for the transportation, keeping and preservation of dead bodies — Amendment

Regulation to amend the Tariff of costs for the transportation, keeping and preservation of dead bodies

WHEREAS, under section 1 of the Act concerning mainly the appointment and the terms of office of coroners and of the Chief Coroner (2020, chapter 20), the title of the Act respecting the determination of the causes and circumstances of death (chapter R-02) is replaced by the Coroners Act;

WHEREAS, under subparagraphs 3 and 4 of the first paragraph of section 168 of the Coroners Act, the Government may, by regulation, after consultation with the Chief Coroner, adopt tariffs establishing the costs of transporting, keeping and preserving dead bodies which a coroner or another authorized person takes possession of and the cost of any other service required for the administration of the Act;

WHEREAS, under the second paragraph of section 168 of the Act, the Government may also, by regulation, determine in which cases, on what conditions and to which categories of persons the tariffs apply;

WHEREAS the Chief Coroner has been consulted;

WHEREAS, in accordance with sections 10 and 11 of the Regulations Act (chapter R-18.1), a draft Regulation to amend the Tariff of costs for the transportation, keeping and preservation of dead bodies was published in Part 2 of the *Gazette officielle du Québec* of 31 August 2022 with a notice that it could be made by the Government on the expiry of 45 days following that publication;

WHEREAS it is expedient to make the Regulation without amendment;

IT IS ORDERED, therefore, on the recommendation of the Minister of Public Security:

THAT the Regulation to amend the Tariff of costs for the transportation, keeping and preservation of dead bodies, attached to this Order in Council, be made.

## Regulation to amend the Tariff of costs for the transportation, keeping and preservation of dead bodies

Coroners Act  
(chapter R-0.2 (2020, chapter 20, s. 1), s. 168,  
1st par., subpars. 3 and 4, and 2nd par.)

1. The Tariff of costs for the transportation, keeping and preservation of dead bodies (chapter R-0.2, r. 7) is amended in section 1

(1) by replacing the table in paragraph 1 by the following table:

(2) by replacing the table in paragraph 2 by the following table:

(3) by replacing “\$83.75” in paragraph 3 by “\$113”;

(4) by replacing “\$30.75” in paragraph 4 by “\$41.50”;

(5) by replacing the table in paragraph 5 by the following table:

Monday to Friday	\$26.75/h	\$32.75/h
Saturday or Sunday	\$29.25/h	\$35.75/h
holiday	\$37/h	\$44.50/h

”.

**2.** Section 2 is amended by replacing the amount “\$45.25” wherever it appears by the amount “\$61”.

**3.** This Regulation comes into force on the fifteenth day following the date of its publication in the *Gazette officielle du Québec*.

## Notice

Automobile Insurance Act  
(chapter A-25)

### Insurance contributions — Amendment

WHEREAS, under the first paragraph of section 151.1 of the Automobile Insurance Act (chapter A-25), the Société de l'assurance automobile du Québec may update, by regulation, the list of makes and models of motorcycles appended to the Regulation respecting insurance contributions (chapter A-25, r. 3.4);

WHEREAS, under the second paragraph of section 151.1 of the Act, such a regulation is not subject to the publication requirement and date of coming into force set out in sections 8 and 17 of the Regulations Act (chapter R-18.1) and comes into force on the date of its publication in the *Gazette officielle du Québec* or on any later date fixed in the regulation;

WHEREAS, by its resolution AR-3106 dated 8 December 2022, the Société made the Regulation to amend the Regulation respecting insurance contributions, which updates the list of makes and models of motorcycles appended to the Regulation respecting insurance contributions;

THEREFORE, in accordance with section 15 of the Regulations Act, the Société hereby publishes the Regulation to amend the Regulation respecting insurance contributions.
